Dear Campership Applicant:

Thank you for considering Eagle's Nest Camp and Hante Adventures for your child. To enable more children to share in our community, a limited number of campers receive financial assistance often in the form of tuition scholarships, called "Camperships." Camperships are awarded with regard to economic status, family need, the child's need for Camp/Hante, and the potential participant's desire to attend our programs.

To be considered for financial aid this coming summer, you must:

- 1) Register your child online via our online electronic registration system, CampDoc.com, or complete and mail-in a paper registration form.
- 2) Pay a \$150 deposit, which is refunded if you do not receive sufficient aid for your child to attend Camp/Hante.
- 3) Complete the following Campership Application.
- 4) Return the completed Campership Application along with the first page of your most recent year's federal tax return to Eagle's Nest Camp, PO Box 5127, Winston-Salem, NC 27113-5127 or email the Application and proof of income to [register@enf.org](mailto:register@enf.org). **Please blackout any Social Security Numbers on the tax form!**

There are two deadlines for the submission of Campership Applications (applications must be postmarked or emailed by the deadline to be considered):

- DECEMBER 1<sup>st</sup>: Deadline to submit registration, application, and deposit for consideration in Round 1 of the awards.
- FEBRUARY 15<sup>th</sup>: Deadline to submit registration, application, and deposit for consideration in Round 2 of the awards.

Applicants who submit their requests by December 1<sup>st</sup> will be notified of awards by the end of December. If you are awarded and accept a campership, a deposit of \$300.00, which is non-refundable after February 1<sup>st</sup>, will be required to secure your camper's spot and Campership award.

Round 2 Applicants:

Families not receiving a Campership award in Round 1 will be reconsidered along with applications submitted after December 1<sup>st</sup> and by February 15<sup>th</sup> in Round 2 of awards. Applicants will be notified of awards for Round 2 by the end of March. If you are awarded and accept a Campership award in Round 2, a deposit of \$300.00, which is non-refundable, will be required to secure your camper's spot and Campership award. We will continue to process applications after the deadlines, depending on the availability of funds.

Most Campership awards are for partial tuition. The largest Camperships awarded assume full need, but still require a minimum contribution from the family. Please understand, each year the requests for Financial Aid/Camperships far exceeds the amount of funding available. Therefore, we cannot guarantee that your full request will be met.

IMPORTANT: Your child must be registered and accepted to an Eagle's Nest Camp Session or Hante Adventures before we can review your application for Financial Aid. If you have not completed the Camp or Hante Registration Form, online or paper, and submitted the \$150 deposit, please do so as soon as possible in order to secure a space in the program of your choice.
