

## **Applying for Financial Aid**

We wish to make The Outdoor Academy available to the widest possible range of students. Therefore, we strive to allocate approximately 10% of our total annual tuition income for financial aid, in addition to funds generously provided through endowment. Any monies awarded by The Outdoor Academy are in the form of a grant that do **not** need to be repaid. Due to finite resources that must support many families, we cannot accommodate every financial aid request, nor will your financial aid package cover the entire cost of tuition.

Financial aid applications are reviewed after a student is accepted, and are awarded based on need. Admissions decisions will not be influenced by financial need. In order to fairly estimate a family's ability to pay, The Outdoor Academy uses the Parent's Financial Statement (PFS Report) of the School and Student Service for Financial Aid (SSS).

Any student regardless of race, color, creed, national or ethnic origin may apply for financial aid. We base our decisions on:

- 1. This personal statement regarding your need for financial aid.
- 2. Your PFS Report.
- 3. The suitability of the applicant at OA as demonstrated in the application process.
