



# Important Policies and

This form is required of all campers and their parents or guardians.

Please sign and upload form no later than April 1st.

Eagle's Nest Camp provides a community-centered camp experience for our campers. It is very important that the parents and campers commit to the following policies and procedures to help ensure that the camp experience is a happy and healthy one for all members of our camp community. Parents/guardians please read the "Reasons for immediate or probable expulsion without refund" below to your camper or explain these to your camper in language they will understand.

**Reasons for immediate or probable expulsion without refund:**

1. Any camper or participant who is found in possession of or using illegal drugs or alcohol or in possession of any firearm during a course or camp session or Hante will be expelled from the Eagle's Nest program immediately. The student will be expelled at the participant's expense, without refund of tuition.
2. Any camper or participant involved in inappropriate sexual behavior, harassment or bullying of any kind is liable for expulsion from the program without refund.
3. Any camper or participant found to be using or being in possession of tobacco products, e-cigarettes, or vaporizers is liable for expulsion. Tobacco and vapor products use by campers is illegal. The Eagle's Nest campus and all Eagle's Nest sponsored programs are smoke free for all staff, students, campers and guests.
4. Any camper or participant who disregards ENF regulations is liable for expulsion from the program without refund. Any conduct that jeopardizes safety, causes injury to the camper or others, is illegal, or could damage ENF's reputation may result in expulsion from the program without refund.
5. Any camper whose therapeutic, behavior, or health needs that Eagle's Nest determines cannot reasonably and safely be supported by camp.

I agree to abide by Eagle's Nest's regulations for campers and to read the policies before camp attendance. I will not possess or use firearms, tobacco, e-cigarettes or vaporizers, alcohol, drugs or controlled substances not prescribed by a physician. A violation of any regulation would be ground for my expulsion, without refund, from the Camp/Hante. We encourage caregivers to talk with their child about the details of and purposes for these policies as well as the consequences for breaking them.

**Contractual Arrangement Between Eagle's Nest and Participant Family (from original application form):**

- I understand that after February 1<sup>st</sup> and prior to the beginning of the session the camper is registered to attend, there is no refund for early withdrawal, late arrival, early dismissal (including illness or injury), expulsion, or no-show. After the start of the session there is no refund. Eagle's Nest highly recommends enrolling in trip cancellation insurance.
- I understand that my child must abide by Eagle's Nest regulations for campers and that possession or use of firearms, alcohol, tobacco, e-cigarettes or vaporizers, drugs, or controlled substances not prescribed by a physician are prohibited.
- I understand the camp has the right to expel without refund any camper or participant who violates any regulation, creates a risk to the health and safety of others, or whose presence threatens the best interest of Eagle's Nest Camp or Hante Adventures.
- I understand that if my child is expelled they will not be able to participant in another Eagle's Nest Foundation sponsored program for at least one year.
- My child is physically fit and has no condition or disease which would create a risk or hardship for others. I will submit the Eagle's Nest forms by April 1st and submit the health care provider form as soon as it is available. **I understand current immunizations, Eagle's Nest medical forms, and medical insurance are required.**
- My child has my consent to participate in all camp and Hante activities including, but not limited to those described in the camp literature, website and video and through presentations by the Eagle's Nest staff. I acknowledge that some activities are potentially hazardous and involve a risk of bodily injury, and I release Eagle's Nest from any liability whatsoever for any risks that are inherent in the activity.
- Unless otherwise informed in writing, Eagle's Nest Foundation has my permission to use my child's pictures, images and video footage in promotion and video promotions.
- In the event of a dispute with, or any type of claim whatsoever against Eagle's Nest Foundation, Eagle's Nest Camp, Hante Adventures, or any agent or employee thereof, we agree that the sole and exclusive proper venue for any lawsuit related to such dispute is in Transylvania County, North Carolina. Any suit filed outside of Transylvania County, North Carolina is subject to dismissal with the costs, including a reasonable attorney's fee, taxed against the Plaintiff.
